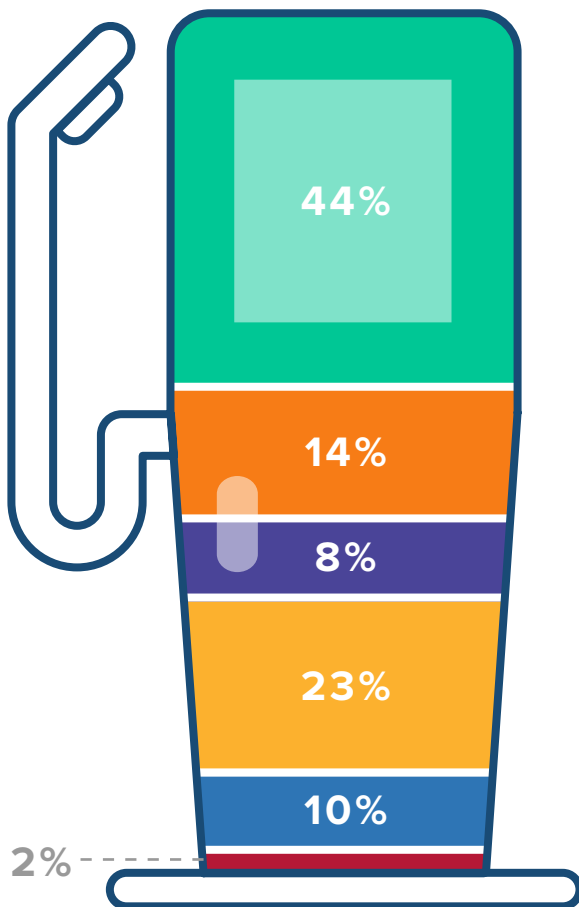


## Estimated Impact of California Taxes, Fees & Cost of Climate Program
